### BOARD ASSESSED FEES

| General Fee (ACT 293)            | This fee is a per credit hour fee with a minimum of \$63.55 and a maximum of \$253.85. The fee supports academics and general educational operations of the University.                                       |
| Excess Credit Hour Fee (ACT 293) | This fee is charged to students taking above 15 credit hours and defrays the additional instructional costs incurred. The fee at 16, 17, and 18 credit hours is \$86.00, \$220.00, and \$354.00 respectively. |
| Academic Building Use Fee        | This fee is a \$10.00 flat fee collected to construct, acquire, repair, maintain, operate, or improve the facilities and physical infrastructure of the institution.  |
| Academic Excellence              | This fee is a \$10.00 per credit hour fee up to a max of \$120 collected to promote academic excellence at the institution by enhancing instructional programs.   |
| Operational Fee                  | This fee is \$4.80 per credit hour fee up to a max of \$57.60 collected to defray mandated costs and, in the event of revenue in excess of those costs, enhance instructional programs.                       |
| Academic Enhancement             | This fee is a \$25.00 flat fee collected to enrich academic educational activities and programs.  |
| Building Use Fee (HB 671)        | This fee is \$4.00 per credit hour fee up to a max of \$48 collected to construct, acquire, repair, maintain, operate, or improve the facilities and physical infrastructure of the institution.              |

| Medical Service-Counseling            | This fee is a \$30.00 flat fee collected to support the operation of the University Counseling Center.  |
| Medical Service Fee                   | This fee is a \$24.00 flat fee collected to support the operation of the University Health Center.  |
| Student Publication Fee               | This fee is a \$6.00 flat fee collected to fund publications such as the Lion's Roar newspaper and Le Souvenir yearbook for students.   |
| Title IX Support Fee                  | This fee is a \$6.00 flat fee collected to support operations of the University's Title IX office.  |
| Student Union Building Fee            | This fee is a \$10.00 flat fee collected to fund renovations and repairs to the Student Union.  |
| Student Union Use Fee                 | This fee is a \$30.00 flat fee collected to support the operation of the Student Union.   |
| Health Center Building Fee            | This fee is a \$6.00 flat fee collected to fund renovations and repairs to the University Health Center.  |
| Student Records Fee                   | This fee is a \$5.00 flat fee to defray the costs associated with production of the student catalogue.  |
| Inst. Evaluation                      | This fee is a \$15.00 flat fee collected to fund evaluation and assessment activities at the institution as required by the University's accrediting bodies.  |
| Alumni Fee                            | This fee is a \$5.00 flat fee collected to expand services, publications, etc. provided by the Alumni Office.   |
| Tinsley Memorial Loan Fund            | This fee is a \$0.15 flat fee, starting at 3 credit hours, collected to fund an emergency short-term loan program which is administered to students through the Financial Aid Office during registration. |
| Utility Surcharge                     | This fee is a per credit hour fee up to a max of \$180.00 collected to defray the cost of campus utilities.   |
| Technology Fee                        | This fee is a \$5.00 per credit hour fee collected to implement, replace, improve, and expand technologies to benefit student life and learning opportunities.  |
| Stu. Technology Resource Fee (HB 152) | This fee is a \$7.00 per credit hour fee collected to furnish computers and other technologies necessary for classroom use.   |

| KSLU                             | This fee is a \$5.00 flat fee collected to support the activities of the University Radio Station.   |
| Campus Activities Board          | This fee is a \$10.00 flat fee collected to fund campus events and activities for students such as Gumbo Ya Ya, Strawberry Jubilee, etc.   |
| Cheerleader Fee                  | This fee is a \$2.00 flat fee collected to support the activities of the Southeastern cheerleading team.   |
| Theatre Fee                      | This fee is a \$2.00 flat fee collected to fund Theatre productions.   |
| Arts/Lecture Fee                 | This fee is a \$0.50 flat fee collected to retain guest lecturers for campus events and activities.  |
| Intramural Fee                   | This fee is a \$12.00 flat fee collected to fund the Intramural Department, which includes the Student Activity/Wellness Center and recreational programming activities for students.          |
| SGA Capital Outlay               | This is a \$5.00 flat fee collected to provide resources for campus improvements as approved by the Student Government Association.  |
| Student Government Asst.         | This is a \$5.00 flat fee collected to provide resources for student research/conference travel, organization projects, etc. through grant applications to the Student Government Association. |
| St. Foundation Endowment School. | This fee is a \$0.75 cent flat fee collected to fund scholarships available to Southeastern students.  |
| Art Gallery Fee                  | This fee is a \$1.50 flat fee collected to support the operation of the Clark Hall Art Gallery.  |
| Lionettes Spirit Fee             | This fee is a \$2.00 flat fee collected to support the activities of the Lionettes dance team.   |
| Varsity Band Spirit Fee          | This fee is a \$5.00 flat fee collected to support the activities of the Varsity Band.   |
